Adult Men's and Women's volleyball is part of an agenda of more than 20 different sports being contested during June and July in the 2010 Aloha State Games — Hawaii's Olympics for the common person. This tournament will take place June 11-13, and June 25-27, 2010 at the McKinley High School gymnasium.

ENTRY FEE – The entry fee of \$20 per team member is designed to cover costs of conducting the tournament, including officials, gym rental, awards and insurance. All division tournaments begin with pool play and conclude with playoffs among the top teams. **Refunds** will be given only if the event is canceled by Aloha State Games.

T-SHIRTS – All persons registering before the **June 6 deadline** will receive a T-shirt. Every effort will be made to supply T-shirts in the size noted on the entry forms; if this size is NOT available, then the next available size will be substituted. **Participants registering after June 6 WILL NOT** receive a T-shirt unless they pay the late penalty (\$5 per person). All T-shirts will be delivered to the tournament venue.

Divisions may be combined if insufficient entries; all entering teams guaranteed at least two pool-play matches.

Requirements: Current USA Volleyball rules regarding uniforms apply: similar top with number of clearly contrasting color; if Libero is used, a different legal uniform is required.

Register Info: DEADLINE JUNE 6; **no entries accepted after June 6;** use Team Entry section below to list all players; all players **MUST** fill out side one of this entry form and sign the waiver; all waivers must be attached to Team Entry Form.

Register Fee: \$20 per team member (entry not required of non-playing coaches).
